# **RUSIŃ-SKI Ski Station REGULATIONS**

## I. General provisions

1. Entering the premises of the RUSIŃ-SKI Ski Station is synonymous with the acceptance of these regulations.

2. The use of facilities and equipment of the RUSIŃ-SKI Ski Station is possible during its opening hours. Opening hours are provided on an ongoing basis on the website of the Station [www.rusin-ski.pl/wyciag] and on the information board. It is forbidden to be on ski lifts and ski runs outside opening hours.

3. Using the ski lift lifts of the RUSIŃ-SKI Ski Station takes place on the basis of a previously purchased subscription (magnetic card). The purchase of a magnetic card means acceptance of the rules of using cableways and rules of using the downhill routes specified in these regulations.

4. Persons staying in the station should exercise due care and act in a way that does not threaten the health, life and safety of other people. You must obey the regulations, including the rules of using ski lifts and ski runs, and follow the signs and instructions for operating the lifts.

5. It is forbidden to introduce animals to the area of ski slopes and to the facilities of the Station. In addition to these areas and facilities, dogs can be introduced to the premises of the Station provided that the owner supervises continuous supervision and uses a short leash and muzzle.

6. It is forbidden to drink alcohol or smoke in the ski lifts and ski runs, and to drink alcohol or people who are in a state of intoxication or after consuming intoxicants.

7. It is forbidden to bring to the Station premises objects threatening the safety of skiing, as well as leaving and throwing away impurities.

8. The operation of all commercial and non-commercial activities on the premises of the station, including conducting commercial and catering activities, conducting ski training, placing advertisements, advertisements and leaflets requires the consent of the manager. The Manager reserves the right to claim compensation from persons running without his consent activities on the premises of the Station.

9. Persons who do not comply with the rules of these regulations may be removed from the RUSIŃ-SKI Ski Station and may be deprived of a magnetic card and the right to return the deposit and payment for unused journeys.

10. The area of the RUSIŃ-SKI Ski Station is monitored.

11. Station employees are responsible for enforcing the provisions of these regulations. In the event of difficulties in enforcing them, employees call the appropriate security services (eg police, the agency for the protection of persons and property).

12. Every customer has the right to ask for additional guidelines or instructions on how to behave on the Ski Station from the RUSIŃ-SKI Ski Station's website.

#### II. Rules for using downhill routes

1. It is possible to drive down only on the ski runs that have been designed for this purpose, at the same time being aware of fire hydrants, cannons or other devices existing on the route. The ski routes are one-way.

2. Admission to ski runs is only possible in designated places.

3. On the ski slopes, pedestrian traffic and sledging or driving down on other objects are prohibited than skiing or snowboarding.

4. Persons practising skiing or snowboarding until the age of 16 are obliged to use a protective helmet, structurally designed for this purpose, under a fine specified in the Act. The employee operating the organized ski area has the right to prevent the use of ski lifts and slopes of people who do not meet this condition.

5. The boundaries of the downhill route are defined by natural boundaries [forest edge, steep slopes, etc.], wire mesh and barriers separating permanent or portable, signs, directional lanes located on the route borders, separation strips, traction of ski lifts, columns with lighting lamps, a trail of a snow groomer and other. The above markings can be used together or individually. The beginning of the downhill route is marked by an information board with the degree of difficulty. The end of the downhill route is marked by an information board as well.

6. A person who is a witness of an accident is obliged to immediately inform TOPR rescuers of the accident by calling under +48 601 100 300 or of other extraordinary events that may affect the safety of persons.

7. Each person is obliged to facilitate the passage of a TOPR rescuer moving on skis or scooter with rescue equipment for transporting people, in particular by immediately yielding the right of way to them.

8. Riding outside the designated route takes place on its own responsibility.

9. The FIS ski code should be followed.

## III. Rules for using the chairlift

1.A customer who has a valid pass has the right to use journeys in the amount specified in the card that was previously purchased. He also has the right to carry free hand luggage weighing up to 10 kg and sports equipment [one pair of skis, poles or snowboard].

2. Entry into the railway area takes place only in places designated for this purpose [entrance gates]. It is forbidden to enter the route of the railway and outside the area designated for getting on and off.

3. Passengers pass through the entrance gate in order, after loading the card and hearing a sound or light signal. The rules for the use of magnetic cards must be observed. If the card is not deleted and any gateway is missed, the service staff may deprive the client of the magnetic card and the right to return the deposit and the amount due for unused journeys.

4. After passing through the entrance gate, the person should take the place in front of the sorting gate.

5. It is forbidden to get on the chairs without a permission. Getting in and out is done only in marked places for this purpose. When getting in, place poles or luggage to the left hand, release the right hand and sit facing the direction of travel at the designated place on the platform. After driving up a chair, should sit on it, helping yourself with a free hand. After taking the place, the secured chairs must be closed immediately. On one chair can sit a maximum of 4 people when using a 4-seat rail or 6 people if using a six-seat rail.

6. Children with a height over 125 cm can use the chairlift. Children with a lower height can only be transported under the care of an adult. Disabled people can only use in the company of a carer.

7. Keep calm and seated while driving. It is forbidden to open the chair closing, rocking the chair, leaning, changing the sitting position to another, transporting children on the knees, making noise, smoking, drinking alcohol and throwing away any objects.

8. We transport skis only attached to shoes. It is forbidden to transport skis in their hands. Skis and snowboards are set parallel to the direction of travel so that they do not cause a collision with other passengers or railway elements. The poles should be held together in one hand.

9. All loosely hanging items of clothing [strings, ribbons, scarves, etc.] should be secured against being caught by the elements of the chair.

10. If the railway stops, do not leave the chair. Expect a resumption of traffic or the dispositions of railway employees.

11. In case of ambiguity, the service provides full information.

12. Failure to comply with the regulations may cause the refusal of the transport.

13. The conditions of carriage form an integral part of the transport contract. They apply to the transport of persons and also concern the behaviour on the territory of the railway.

14. A passenger, despite having a valid ticket [carnet], has no right to demand carriage if it is impossible due to atmospheric conditions or during breaks between planned trips, or if the work is impossible due to other reasons.

## IV. Rules for the use of T-bar lifts

1. The platform may only be entered with the consent of the operator in the place marked for this purpose.

2.Admission takes place only in designated places [entrance gates]. It is forbidden to enter the T-bar lift route outside the designated area.

3.Passengers pass through the entrance gate in order, after loading the card and sound signal. The rules for the use of magnetic cards must be observed. If the card is not deleted and any gateway is missed, the service staff may deprive the client of the magnetic card and the right to return the deposit and the amount due for unused journeys.

4. After passing through the entrance gate, take the place in front of the sorting gate.

5. Only one person can ride on a T-bar lift.

6. The start of the ride is only from the bottom lift station. Ski or snowboard should be placed parallel to the route, grab both poles with one hand [the stick strap cannot be hung on the hand], with the other hand catch the T-bar lift.

7.Drive along the designated track under the rope, holding the pole. It is forbidden to touch other elements of the ski lift while driving, picking up empty T-bars on the route, as well as deviating from the designated route of the lift or slalom driving.

8.In the event of a fall, immediately descend the T-bar and remove it quickly from the track.

9.If the lift is stopped while driving, please wait for restarting or follow the operating instructions.

10.Do not let off the T-bar before the drop-off zone. At the top station immediately leave the platform in the designated direction. It is not allowed to continue driving outside the drop off zone.

## V. Rules for the use of a belt lift

1. The use of the belt lift is only possible in the presence of service.

2. Follow the operating instructions.

3. Children under 5 years of age may use the device only if accompanied by an adult who will familiarize the child with these rules.

- 4. Keep a safe distance between passengers when passing the conveyor belt
- 5. Skis, snowboards should be laid flat on the tape along the course.
- 6. It is forbidden to place skis, poles or snowboards outside the strip.
- 7. After leaving the hill, immediately leave the lift belt in the designated direction.
- 8. In case of any doubts, the service provides full information.
- 9. Failure to comply with the above rules may be the reason for refusing to pass a belt lift.

get by of children under 5 years without the supervision of an adult person. The rules for the use of a belt lift form part of a transport contract. Each ticket buyer accepts the above conditions.

#### **VI. Technical Support**

During the preparation of organized ski areas or their fragments with snow machines, the routes will be temporarily closed for ski and snowboarding. The manager of an organized ski area reserves the possibility of periodically closing all or part of the ski slope in order to organize competitions, training, training, etc. At this time it is forbidden to use it by unauthorized persons.
